RESOLUTION NO. 247

CAME ON TO BE CONSIDERED the Certification of Unopposed Status regarding the Yoakum Hospital District General Election to be held on the 2nd day of May, 2020, for the purpose of electing two members to the Board of Directors for three year terms each, and it appearing from said certification by the authority responsible for the preparation of the official ballot for the May 2, 2020 election:

- * that the filing deadline for place on the ballot for the general election (5:00 p.m., February 14, 2020) and the filing deadline for write-in candidacy for the general election (5:00 p.m., February 18, 2020) have both passed;
- * that there were two candidates who filed for the general election before the deadline, towit: Linda Schmidt (who filed on January 23, 2020), and Harry Sherman (who filed on February 6, 2020);
- * that each candidate whose name is to appear on the ballot is unopposed;
- * that no write-in candidates have filed to be placed on the list of write-in candidates; and
- * that no proposition is scheduled to appear on the ballot.

BE IT RESOLVED AND ORDERED that the Yoakum Hospital District, by its Board of Directors, in accordance with law and the Legislative Act governing the Yoakum Hospital District, that LINDA SCHMIDT and HARRY SHERMAN are hereby declared duly elected and shall each serve for a term of three years to said respective offices, subject to their signing of the Statement of Elected Officer and to the taking of their oaths as provided by the laws of the State of Texas.


